## **Product Use Instructions – Clean Vinyl Technology™ Protective Gown (Sleeved)**

**Product:** Clean Vinyl Technology™ Protective Gown incorporating an antimicrobial. Single piece with full length sleeves seamed/sealed in a non-critical area for FDA Class 1 usage.

**Use:** Personal Protective Equipment (PPE). AAMI/ANSI PB70 Level 1, 2 and 3. Typical usage is patient screening, specimen collection, lab, urgent care, routine office care, lobby, security, foodservice, food manufacturing and similar settings. Not for invasive/surgical settings (FDA Class 2).

**How Use:** (1) Remove from package, unfold and remove one by one. (2) Locate belt tabs. (3) Pull over head, position comfortably and then securely tie behind you. Your back will be partially uncovered for comfort and ergonomic considerations. Don't forget to tuck each sleeve into your glove. (4) To remove, tear from the neckline down and outward (there is an approximate 1.0-inch slit front and back), then remove in a downward motion and step out. (5) When removed, fold outside into inside and discard appropriately.

**Cleaning:** Single use. If desired, gently hand wash with soap and water or mild detergent. Rinse thoroughly and air dry. Do not expose to temperatures  $\geq 200^{\circ}\text{F}$ . No direct contact with heat source or heating element.

**Recycling and Disposal:** Noncontaminated gowns can be recycled (Plastic No. 3). If exposed to bio-hazards and/or contaminated, follow the protocol established by your facility, don't recycle and keep out of the general (non-bio hazard) waste stream.

**Traceability:** Each carton is labeled with item number, date of manufacture and lot number.
